## Assistive Technology: Helping Children Participate and Learn

We all know that an inclusive setting is beneficial for children. However, it is very important that we think not only of children *being in* the general education environment, but that they are given the opportunity to *participate* as fully as possible, both academically and socially. This requires educators, families, and students to put their heads together and consider ways to gain access to everything that is happening in the educational environment. The key to this access is Assistive Technology (AT)!

The team, including the family and student, needs to carefully consider what environments the student is in, what tasks the student is required to accomplish, and what challenges the student has in accomplishing the tasks. If a student has difficulty with a task, they should be taught the skill or information, but also may need to compensate for that difficulty or bypass the barrier so they can learn to their full potential. This process of thinking through what is difficult, but necessary to do will allow the team to figure out the current need(s). Then ask the question—Would assistive technology of some kind enable the student to meet the goal? Continued on pg. 2

Areas of AT to consider that may be a barrier for your child could be: Handwriting, Spelling, Reading, Math, Written expression, Daily organization, Communication, Mobility, Recreation, Computer Access, Seating/positioning, Seeing, Hearing, Self-care, Levels of independence, Cognitive processing, etc. By using AT to get around those difficulties, your child can experience success with greater independence in the classroom, in the community, and even at home.

**Lifespan Transitions Center:** The Lifespan Transitions Center offers resources, training, technical assistance, and consultation to support the successful transition of individuals with autism and multiple disabilities throughout their school careers and into their adult lives. Resources address community living and employment.

**Family Center:** The Family Center at OCALI connects families to the information they need regarding services, supports, training and resources, including the free OCALI Lending Library. It offers training and products to help families and to support agencies serving them.
